Presentation from Conservation Foundation of the Gulf Coast Regarding McCall Ranch

Christine John, President of the Conservation Foundation of the Gulf Coast and Debbie Osborne Director provided a PowerPoint presentation regarding the preservation of Orange Hammock Ranch. Discussion ensued regarding: (1) currently, there is not a plan for the property; (2) the property meets the Florida Forever Projects; (3) the application was submitted for future funding; Commissioner Yates and Mayor Blucher expressed concern with including the entire property and not having a plan for the property; (4) the City has a future use plan for the property; (5) the owner wants to sell the property; (6) Mayor Blucher stated that he does not want the County, or State thinking that the City of North Port supports the entire property being use for conservation; (7) The Florida Forever application, is just an approval of the land owner to submit to get on the list for potential future funding, specific plans are not required. Thereafter, public comment was held.

## **6. PUBLIC HEARINGS:**

## A. 14-0443

Ordinance No. 2014-30, second reading, Code Enforcement Special Magistrate.

Subsequent to City Clerk Raimbeau reading the Ordinance into the record, Attorney Robinson provided a brief overview.

Discussion ensued regarding: (1) it was noted that additional backup was provided and it was questioned why this was not included in the backup that was provided prior to the meeting; (2) it was clarified that the Special Magistrate was appointed at the previous meeting and this was just second reading of the Ordinance; (3) it was further explained that if the Ordinance does not pass on second reading than there will not be a Special Magistrate, but if the Ordinance passes then Attorney Robinson will become the Special Magistrate effective October 1, 2014; (4) Commissioner Yates expressed concerns about dual office holding in regards to Attorney Robinson being appointed both as Zoning Hearing Officer and the Special Magistrate; (5) Commissioner Yates stated that she would like to continue the Ordinance until after the new City Attorney begins with the City and believes that by approving the Ordinance the Commission will be appointing someone to hold dual offices; (6)The Ordinance conflicts with the Charter in regards to the duties of the City Attorney relating to Code Enforcement. Thereafter, public comment was held.

A motion was made by Commissioner Cook, seconded by Commissioner Jones, to approve Ordinance No. 2014-30. The motion carried by the following vote: Commissioner Yates dissented for reasons stated previously

#### B. 14-0462

Ordinance No. 2014-27, first reading, amending section 78-31of the City of North Port Code of Ordinances relating to responsibility for collection, distribution and transmission costs.

A motion was made by Commissioner Jones, seconded by Commissioner Cook, to read the Ordinance by title only. The motion carried by the following vote:

Subsequent to City Clerk Raimbeau reading the Ordinance into the record, City Manager Lewis and Interim Public Utilities Director Newkirk provided an overview of Ordinance No. 2014-27 and Business Manager Desrosiers provided a Power Point Presention of the changes necessary to implement the expansion program.

Discussion ensued regarding: (1) the payment arrangement process for citizens; (2) it was noted that this is a voluntary expansion program; (3) it was explained that the seller can negotiate the remaining balance with the buyer of the property; (4) it was clarified that if the property is owned buy two individuals, one individual could continue with the payment plan in the event of death, divorce etc.; it was noted that the ordinance would be change to reflect the removal of the Tamami Trail Appearance Review Board, which no longer exist: (5) additional pilot programs will be brought to the Commission for approval, prior to being implemented. There was no public comment.

that Ordinance No. 2014-27 be continued to the September 22, 2014 Commission Regular Meeting for second reading. The motion carried by the following vote:

A motion was made by Commissioner Cook, seconded by Commissioner Jones, to continue Ordinance No. 2014-33 to the September 22, 2014 Commission Regular Meeting for second reading. The motion carried by the following vote: Mayor Blucher dissented for reason stated above.

City Clerk Raimbeau read Resolution No. 2014-R-16 into the record by title only.

Mayor Blucher provided a brief overview.

Danny Bileu representative for Congress Vern Buchanan's Office was present to answer questions.

Discussion ensued: (1) subsequent to a question, Mr. Bileu reported that they are looking to reallocate some funding from mental health programs, but do not want to take away from one program to fund another; (2) Mr. Bileu stated that having the Town Hall meetings has brought an awareness to which areas of mental health need to be improved. There was no public comment.

A motion was made by Vice-Mayor DiFranco, seconded by Commissioner Yates, to approve Resolution No. 2014-R-16. The motion carried by the following vote:

City Clerk Raimbeau read Resolution No. 2014-R-17 into the record by title only. City Manager Lewis provided an overview of the Resolution.

Discussion ensued: (1) subsequent to a question, it was clarified that the survey has not been completed and that there was a minor title issue regarding vacation of some roads; (2) a closing date has not been set; (3) it was noted that more information will be available after the County Commission meetings tomorrow; (4) it was requested that Mayor Blucher attend the County Commission Meeting tomorrow (September 9, 2014); (5) Mayor Blucher stated that he will not vote in support of the Resolution, he is not in favor of purchasing Sarasota County's portion of Warm Mineral Springs. There was no public comment.

A motion was made by Commissioner Yates, seconded by Vice-Mayor DiFranco, to aprove Resoluiton No. 2014-R-17. The motion carried by the following vote: Mayor Blucher dissented for reason stated previously.
